Dear Ms. Fields and Mr. Borland:

In anticipation of the release of the Draft Environmental Impact Statement (EIS) for the Port Ambrose liquefied natural gas (LNG) deepwater port this month, the undersigned groups hereby request that MARAD and USCG provide for at least 90 days of public comment and schedule at least three (3) public hearings in each adjacent coastal state, i.e., New York and New Jersey.

We understand that the project applicant, Liberty LNG, is entitled to have its application handled in a timely way, but the public also has a right to fully consider the impacts of an LNG port that could pose a major security threat in a densely populated area, risks burdening the region's ecosystems and public health with air and water pollution, and will tend to discourage investment in renewable energy supplies and energy conservation. Considering that the applicant has had well over one year to review and address the over 200 data gaps identified during scoping, the public deserves sufficient time to review the new data and findings that will presumably be incorporated into the Draft EIS; 45 days is disrespectful of spirit of public involvement. Also, given the scale of the project and the broad scope of potential environmental impacts, there is significant public interest across Long Island, the Jersey Shore, and beyond. It is unreasonable to expect that citizens from such a large geographic region will be able to attend one of only two public hearings.

Furthermore, with the Draft EIS expected to be released before the end of the year, the winter holidays will inevitably fall within the public comment period, with the public hearings likely being scheduled shortly after the New Year. Late December into early January is one of the most popular times of year for Americans to take time off from work and travel to spend the holidays with family. This timing will make it difficult or impossible for many interested parties to attend the hearings or to prepare for meaningful public participation. This is disappointing,

given that the last round of public hearings (of which there were only two) was scheduled for the week following the Fourth of July weekend in 2013, also typically one of the most popular vacation weeks of the year. Good governance requires that the public has sufficient opportunity for meaningful input throughout the permitting process, which is not possible within 45 days and at one hearing per state.

For these reasons, we respectfully request that the Maritime Administration use its statutory authority to stop the Deepwater Port Act clock for an extended public comment period of at least 90 days and schedule a minimum of three (3) public hearings each in New York and New Jersey.
