Student Activities Overview

Introduction to Diamondback Terrapins

Terrapins are turtles that inhabit estuaries along the east and Gulf coasts of the United States. Terrapins were harvested in the late 1800's through the early 1900's as a food source with a high demand leading to reductions in their populations across their range. Students learn about the life history of this species, interesting variations in their markings attributed to genetic diversity, its role in the ecosystem, and how we have impacted the species. Researchers in the field will also provide a brief discussion about diamondback terrapin conservation and wildlife practices.

Activity Roundtables: An Environmental Extravaganza!

The roundtable portion of the Student Summit includes an interactive series of work stations with a variety of hands-on activities for students to learn about the environment. Some of the topics covered MAY include meteorology, marine invertebrate anatomy and identification, nonpoint source pollution, and climate change. All students will participate in the roundtable activities.

Field Workshops

Schools and classes will be divided and a student will participate in **one** of the field activities. The goal is that each school will have students who have attended all field workshops and will share their experiences with fellow students in school. Examples of possible workshops include:

Seining and Marine Animal Identification

New Jersey's estuaries offer a variety of habitats as important breeding, feeding, and nursery grounds for a diversity of fish and invertebrate species. Many of these species spend only a part of the year in area waters, while other species reside year-round within certain coastal habitats. Students will use seine nets and sieves to collect fish and invertebrates to capture, observe, identify and then release common marine animals found in the local bays.

Exploring IBSP from Ocean to Bay

Island Beach State Park is a natural barrier beach at the southern tip of a barrier island. On a walk from the Atlantic Ocean side to the Barnegat Bay side of the park, a group of students led by a naturalist will explore the features of a fully developed dune environment and observe succession. Tice's Shoal and Fisherman's Walkway provide a cross section of a barrier beach.

Birds of the New Jersey Shore

New Jersey is within the Atlantic Flyway, providing a diverse viewing of coastal birds throughout the year. Students will join local birding experts in a survey and identification of coastal birds as part of their workshop.

Seining and Marine Animal Identification

New Jersey's estuaries offer a variety of habitats as important breeding, feeding, and nursery grounds for a diversity of fish and invertebrate species. Many of these species spend only a part of the year in area waters, while other species reside year-round within certain coastal habitats. Students will use seine nets and sieves to collect fish and invertebrates to capture, observe, identify and then release common marine animals found in the local bays.

Marine Water Quality Monitoring

Monitoring of surface water quality is an important source of information used by scientists and environmental managers to characterize water resources, identify water quality problems and trends, and develop water quality management strategies. Participating students will learn about the water quality approach to aquatic resource assessment by collecting and analyzing water samples.

Understanding Marine Debris

Marine debris includes trash and other objects that get into the marine environment as a result of careless handling and disposal. The problem of marine debris has emerged as a critical environmental issue worldwide. Debris in the marine environment is not only aesthetically unpleasant, but it harms marine life and litters the shore. Students will learn about the types, quantities, and sources of marine pollution plaguing our coastal region and participate in a cleanup.

COA's Fall Student Summit Terms of Participation:

The program is *free* to all participants. However, *schools must provide their own transportation and lunches*. To ensure a commitment from your school, a *refundable* **deposit of \$100** must be sent with the application. The deposit will be returned upon your completion of the post-Summit teacher and student evaluations. <u>Space is limited</u>. Therefore, COA has established the following guidelines. In submitting this application, you must understand and agree to these terms of participation:

- ♦ Maximum number of students from each school is 30.
- ◆ Students, teachers, and chaperones are assigned to groups in the Summit. Students and chaperones will be separated and divided among all field trips so that each school will have students who have attended all activities. Students will be mixed with other schools. No changes will be permitted. Groups are limited in size due to space on field trip buses and to allow for interactive sessions.
- ♦ Arrival time is by 8:45 am sharp. Departure time is anytime after 12:30 PM. If schools are unable to arrive promptly at 8:45 am, schools should not apply. Late arrivals may be put into a modified program.
- Schools are responsible for their own transportation to and from the Summit.
- All students, teachers, and chaperones must bring their own lunch. Facilities to buy lunch are <u>not</u> available. Light snacks and drinks will be provided by COA during the program's snack break.
- ♦ Schools must bring 1 chaperone/teacher per 10 students. Chaperones will be required to assist in monitoring students from all schools during the Summit. Teachers, please pass along these terms to all chaperones!
- ◆ COA reserves the right to exclude or limit participation to anyone whose behavior or dress (see below) is inappropriate or disruptive to any attendees' learning experiences.
- ◆ Teachers and students must demonstrate a desire to learn about the marine environment (see application), and complete and submit Pre-Summit forms assessing knowledge about the marine environment.
- ◆ Participation is limited to a total of 500 students each day.
- Students must bring their own pencils and clipboards.
- COA will provide schools with bags for their trash (black) and recyclables (white) for lunch. Schools must bring their garbage bags out of the park and back to school for proper disposal.
- ◆ Students, teachers, and chaperones may be photographed or filmed by COA during the Summit. Teachers must notify COA before the Summit if any student(s) cannot be photographed. Students who cannot be photographed must complete a Non-Permission Release Form (provided in program acceptance materials), and the teacher must present it to COA staff upon arrival on the day of Summit.

About the Summit:

The Student Summit expands learning beyond the classroom. It is designed to provide middle school (Grades 5-8) students who come from different areas of the state with an opportunity to experience hands-on, marine environmental education at the Jersey Shore. The activities included in the Summit have been selected to present students with an interdisciplinary marine and environmental education experience.

Who can apply:

Schools located in Southern NJ Counties: Atlantic, Burlington, Camden, Cape May, Cumberland, Gloucester, Ocean & Salem.

Summit Location: Island Beach State Park in South Seaside Park, NJ. Applications accepted through <u>September 19, 2019</u>.

How To Apply — Three Easy Steps

<u>Step 1: Agree to Terms of Participation:</u> Carefully review the terms. Send the initialed and signed copy of the terms in with the completed application. They are used to ensure all participants have a productive day.

<u>Step 2: Complete Application Form:</u> Complete the application form. Mail form (with refundable deposit (make checks payable to Clean Ocean Action) to *be received by Clean Ocean Action* by <u>September 19</u>, <u>2019</u>.

Step 3: Send Application, signed and initialed Terms, and \$100 Refundable Deposit to: Clean Ocean Action, "Student Summit," 49 Avenel Blvd., Long Branch, NJ 07740. You will be advised about acceptance as soon as possible after the deadline. In the meantime, we suggest you make bus reservations and arrangements and receive the necessary approval from your school.

Costs/Refund: The program and all materials are *free*. Transportation and lunch must be provided by participants. To ensure a commitment from your school, a refundable deposit of \$100 is required with your application. The deposit will be returned upon your completion of the post-Summit teacher and student evaluations. Post-Summit evaluations not received by COA by December 1, 2019, will be cashed and used as a donation toward the Student Summit program.

Dress Requirements:

Coastal locations are usually cold and windy. Advise the students to dress according to the weather, bring additional layers of clothes, and wear sneakers or hiking shoes. COA reserves the right to exclude or limit participation to anyone whose dress is inappropriate.

Weather Advisory - No Rain Date

Appropriate outerwear is mandatory; noncompliance may result in the student's participation being restricted by staff.
