



Surfer's **Environmental Alliance** (SEA) is a grassroots organization committed to the preservation and protection of the environmental and cultural elements that are inherent to the sport of surfing.



SEA was founded in 1991 by surfers who wanted to do something to protect the ocean, beaches, and coastlines. Based in Northern California and New Jersey. SEA is currently working on independent water quality tests during storm activity in the winter months, beach access, and the right to surf during hurricane swells.

Since Clean Ocean Action began its fight against liquefied natural gas, SEA, and especially Richard Lee, a SEA national board member, has been an active coalition partner. They fought alongside us every step of the way. "There are few things you can count on; if it will clean up the ocean, COA is for it. If it will industrialize or pollute the ocean, COA is against it. I'm proud of SEA's affiliation with COA and will continue to fight to establish the Clean Ocean Zone," said Richard Lee.

SEA continues to partner with COA on water quality related issues and on the

Student Ocean Advocates (SOA) are representatives from high schools in Monmouth and Ocean Counties that meet bi-monthly at Monmouth University and Ocean County College where they learn about ocean related issues and produce a student-run campaign aimed at addressing a current ocean threat.



This year 50 students from 16 schools participated. During the program, students learned about the process of advocacy and tools/techniques they can use to create change in their community. Drawing on their new skills, the students dove into their chosen issue and develop a campain to address the problem.

The SOA's from Monmouth County are working to reduce bottled water consumption in order to reduce the amount of plastic ending-up in the marine environment. Their projects included presenting about the environmental harms from bottled water, having bottled vs. tap water taste tests, pledges to stop using bottled water, and bottled water sculptures displays.

The SOA's of Ocean County have been fighting nitrogen pollution in Barnegat Bay caused by fertilizer use. They used the Barnegat Bay Buddy program to educate and recruit new environmental stewards. They also



gave presentations to their schools, set up informational tables and displays, and were featured in the morning announcements. Ocean County SOA's will also be featured in the Jellyfish Symposium. The group learned a great deal about advocating at a moments notice and were featured on the student-ran radio station at Ocean County College! Way to go SOA's!

Disaster in the Gulf: One Year Later


April 20, 2011 marks the one-year anniversary of the BP Deepwater Horizon disaster. Marine life and the environment have been extensively damaged by the oil and natural gas released. Yet, since that time, no new laws have been passed in response to the disaster to prevent such a situation in the future. The Federal Agency in charge of offshore energy development is still undergoing reforms. After the BP disaster, deepwater drilling permits were suspended due to the lack of adequate oil spill response plans and capabilities. Earlier this year, the suspension was lifted, despite the lack of implementation of substantive changes.

With increasing oil prices, many politicians are calling for more domestic drilling in the Atlantic, Arctic, and Pacific. Although the Atlantic Coast is protected from offshore drilling for the next 5 years, the policy could change with political pressure. Increased offshore drilling will not affect gasoline prices. We are still exporting more oil overseas than ever before.

Testimony: NYC Sustainable Dredged Material Management Policy

On March 8, 2011. COA testified before the New York City Council's Committee on Waterfront Management on Developing a Sustainable Dredged Material Management Policy. Making such a policy citizen-based is critical as meaningful public input and education are necessary for successful management outcomes.

COA explained that NJ's dredging program can serve as a model for carefully regulating dredged material, coordinating activities involved, and facilitating beneficial reuse for beach replenishment, brownfield remediation, landfill closures, and other purposes. Only after this protective regulatory system was developed was New Jersey able to exempt dredge material from its previous classification as solid waste.

COA recommended that both New York City and NY state become more involved in NY/NJ Harbor dredged material management to create a more consistent and collaborative bi-state program. COA also urged adoption of the Regional Sediment Management Plan and implementation of its recommended actions, as a sustained regional effort is vital for managing dredging needs in the Harbor.

Until a more robust regulatory program and process are put in place in New York and the resolution is clarified, however, COA could not support a council resolution to declassify clean dredged material. Full testimony can be viewed at cleanoceanaction.org

New Jersey Spill Act Liability

In March, the New Jersey Assembly is slated to vote on a bill that the State Senate passed almost unanimously in mid-December – the lifting of liability caps for oil & hazardous material spills that occur outside New Jersey but affect the State's citizens, businesses, and environment.

This bill would make all "persons" (which includes everything from actual people to boats, oil rigs, and gas refineries) liable for clean-up costs and any and all economic damages that result from their spills.

Update on the New Jersey Budget

Governor Christie proposed 2011-2012 budget increases the funding for Department of Environmental Protection programs by 5.3% over this year's levels, to just under \$350 million. Specifically, the Governor boosted funds available for cleaning up toxic sites, implementing water quality improvements, expanding parks and park budgets, and ensuring that the DEP will not suffer reductions in staff.

The Governor also proposes not to divert Regional Greenhouse Gas Initiative Fund for use in other programs, as had happened last year.

Clean Ocean Action Wind Policy

COA finalized its policy position on offshore wind energy development ("OSW"). In the policy statement COA stresses the need to reduce fossil fuel reliance and use through conservation and efficiency. It is COA's position that any offshore renewable energy facilities' development must be "responsible" - pre-planning, oversight, and precaution must go into all OSW decisions. The COA OSW policy will be posted on our website soon.

Coastal Creature Feature

The February creature feature was the Minke Whale (Balaenoptera acutrostrata), which is also called Little Piked for its small size and pointed beak. Minke whales are thought to have a complex social structure, as they are sometimes sighted alone, in small groups, and in larger groups (400 or more) in feeding areas. About 185,000 minke whales live in the Atlantic. These baleen whales make a variety of vocal noises and use low-frequency sounds to communicate. Increasing noise pollution in the ocean is a concern. The April creature has a grayish white crusty outer shell and smooth inner shell that grows up to 8-14 inches. They live in brackish estuarine areas that have hard sand, shell or firm mud bottoms. They stick to each other forming reefs that create habitat for fish and other creatures. Water pollution, disease, and habitat impacts have decreased populations from much more abundant levels in the past. There are restoration efforts in our region.


