STOP THE WILLIAMS-NESE PIPELINE!

Williams/NESE Pipeline project indicated in RED

The project will also:

- destroy our water quality and harm marine life;
- increase air pollution;

- may lead to an offshore Liquefied Natural Gas (LNG) export facility; and
- is a threat to public safety.

The NJ Department of Environmental Protection (NJDEP) is accepting comments on the NESE project until April 3, 2020. The NJDEP previously denied the applications due to the significant environmental harm and lack of need.

In accordance with a settlement agreement with the New York Public Service Commission, National Grid will conduct public hearings on future methane gas supply options, including the proposed NESE Pipeline. National Grid is the largest natural gas provider in the Northeast. COA urges people to attend these hearings as another way to show opposition to NESE. Learn more at ngridlongtermsolutions.com.

Nasty NESE is Back! Stay Strong!

NESE is back, they're trying to wear us down! For the fourth time, Williams-Transco is seeking to build "NESE," or the Northeast Supply Enhancement Project, which is a massive \$1 billion fossil fuel project to send New York fracked methane gas. The proposed project consists of a 23.4-mile offshore pipeline and an air-polluting compressor station in Franklin Township, NJ. The pipeline cuts through the heart of Middlesex County, NJ, and rips Raritan Bay/ Lower New York Bay in half, terminating in the ocean off the Rockaways.

The ecological and public health consequences will be devastating and continue for 50 years — or more. Over a million tons of toxin laden muck will pollute the water and the health of the marine ecosystem. In addition, NESE proposes to dump the muck in the ocean.

Stop NESE! Three Actions YOU Can Take NOW!

- 1. Submit Comments Go to www.nj.gov/dep/nese and tell NJDEP to: (1) extend the public comment period, (2) hold public hearings on the proposed project in the Monmouth County Bayshore Area, and (3) deny this unnecessary and environmentally destructive project once and for all.
- 2. Call NJ Governor Murphy at (609) 292-6000 to urge him to say "NO" to NESE.
- 3. Collect petition signatures and join the movement to defeat NESE by contacting COA's Kari Martin (732-872-0111; citizens@cleanoceanaction.org).



COA Joins Fishermen for Discussion on Offshore Wind

There are currently no wind turbines off the Jersey Shore, but this decade will change that. Governor Murphy has pledged to develop 7,500 MW of offshore wind energy by 2030. COA is committed to ensuring that all offshore wind development in the NY/NJ Bight is done in the most environmentally responsible way. To do this, COA will work with all interested stakeholders to learn and understand specific concerns related to offshore wind development. In February, COA attended a meeting held by Anglers for Offshore Wind, to better understand the thoughts and concerns of recreational fishermen in New Jersey.

COA Contributes 195lbs to TerraCycle's Beach Plastic Cleanup Program

Throughout summer 2019, over 850 volunteers from 29 corporations collected 195lbs of rigid plastic during COA's Corporate Beach Sweeps for a special recycling partnership with TerraCycle. They will clean and recycle the rigid plastic collected and turn it into pellets that will be re-used to make products such as shampoo, soap and skincare bottles. Rigid plastic includes items such as plastic bottle caps and lids, plastic pieces, toys, cigar tips, and single-use utensils, which are not



typically recyclable without TerraCycle's unique Beach Plastic Cleanup Program.

OUTREACH & EDUCATION Climate Change Education Coming to NJ Schools



Single-Use Plastics Bill Stalls in NJ Legislature

Last year, New Jersey failed to pass statewide plastic reduction legislation. NJ's legislation would: 1. Ban all single-use plastic film bags; 2. Ban single-use paper bags (only at grocery stores); 3. Ban all Polystyrene foam food service products; and 4) Allow plastic straws by request. A Senate Committee passed the bill and is planning an important floor vote.

In the meantime, you can help support the state bill by making sure your town has passed an ordinance. There



- 1. Check the list on COA's website to see if your municipality has passed a plastic reduction ordinance. If yes, hooray and help others! If no, read on!
- 2. Bring COA's model ordinances (visit CleanOceanAction.org) for banning singleuse plastic straws, bags, and polystyrene (Styrofoam) foam food containers to your next town council meeting and urge them to adopt it.
- 3. Let COA know your success and continue to advocate for a plastic-free ocean by participating in our statewide Beach Sweeps on April 25.

NY Bans Plastic Bags, Effective March 1

Starting March 1, 2020, a bag waste reduction law will take effect in New York State where over 23 billion plastic bags are typically used each year. Unfortunately, the final regulations allow for thicker 10 mil plastic bags as options. Enforcement begins April 1st. For more information about NYDEC's plastic bag rules, go to www.dec.ny.gov.

National Plastic Reduction Act Introduced

US Senator Tom Udall (NM) and US Representative Alan Lowenthal (CA) introduced the "Break Free From Plastic Pollution Act" on February 11, 2020. It is the first comprehensive bill introduced in Congress to address the plastic pollution crisis. Senator Booker (NJ) is a co-sponsor. The Legislation would phase out unnecessary single-use plastic products, hold corporations accountable for wasteful



products, reduce wasteful packaging, and reform our broken waste and recycling collection system.

According to the Congressional members, "the bill will reduce the amount of unnecessary and wasteful plastic that is created and reform the broken waste and recycling collection system that has led to this catastrophe." The bill awaits review and action in various Congressional Committees.

Trump Continues Rollback of Environmental Protections

In the latest attack on the environment, the Trump Administration has finalized the Navigable Waters Protection Rule. The rule significantly limits the scope of waterways protected under the Clean Water Act, the nation's strongest protection



for water quality. The rule strips away needed protections for streams, wetlands, and groundwater. The rule will take effect on March 30, 2020. Several environmental groups have already threatened to challenge the rule in court.

On February 18, COA hosted a training session for volunteers interested in weekly water quality sampling of the Navesink River. Eighteen new volunteers met at Monmouth Boat Club, which offered an ideal riverfront location to demonstrate proper sample collection

COA's Rally for the Bay Underway in Ocean County!



COA has been serving on the Barnegat Bay Partnership's Advisory Committee (AC) and Scientific and Technical Advisory Committee (STAC) for many years. The many threats and changing ecosystem of the Bay include impacts from sea level rise and climate change. COA's Staff Scientist Dr. Swarna Muthukrishnan attended the meetings.

US Army Corps of Engineers shared updates on Barnegat Bay's participation in the nationwide pilot program for the beneficial use of dredged material. The Partnership also provided an update on the ongoing real-time and continuous water quality monitoring in three stations in the Bay – Beach Haven, Mantoloking and Seaside Heights. The study is being conducted in collaboration with NJDEP and the data is available at http://njdep.rutgers.edu/continuous/.

COA's active participation in the Partnership will be immensely useful in understanding local pollution issues as we gear-up the "Rally for the Bay" program to track down and eliminate pollution from human sanitary sources in the Toms River watershed under the NJDEP 2018 Water Quality Restoration Grant.

Staff Updates

As of February 2020, Kari Martin returns to her Policy & Outreach roots as COA's Advocacy Campaign Manager. She will be leading citizen action campaigns related to reducing plastic pollution, fighting the NESE project, promoting the Municipal Blue Star program, and other ocean pollution issues.

Additionally, Zack Karvelas is now Outreach Associate and responsible for assisting in outreach and campaign initiatives, as well as coordinating volunteers.
