

## Big Oil Ocean Assault Bill Pending

An outrageous pro-offshore oil drilling bill was the focus of a hearing this October in Washington DC. Called the Accessing Strategic Resources Offshore Act, it would remove nearly every regulation and streamline the process to make current offshore oil and gas drilling laws (already weak) obsolete. Here are a few provisions:

- Allow drilling anywhere in federal waters at any time—rendering irrelevant the existing law that requires a public review process, as well as required environmental, social, and fiscal safeguards.
- Strips the right of a President to establish marine national monuments or to withdraw other areas from consideration of drilling.
- Bribe states and communities by offering more revenue-sharing dollars the closer the rigs are to their coast.

Eliminating restrictions on Big Oil is wrong for many reasons.

- 1) Oil exploration and drilling is dangerous for people, and harmful and polluting to the planet.
- 2) Fossil fuel expansion is antithetical to the energy future needed for a sustainable world.
- 3) The current law is already weak, and allows as much drilling as the current President would seek to allow. However, at least it does require public review.

COA will monitor this monstrous proposal and keep you posted. In the meantime, the fast-tracking of the current oil and gas proposals off the Atlantic coast continues under the Trump Administration. Final decisions are expected by the end of the year and hearings planned for the holiday/ new year holiday season.....of course.

Here are the state and local ballot questions that will directly impact the environment questions for your review.

#### New Jersey Public Question #2: The Revenue from Environmental **Damage Lawsuits Dedicated to Environmental Projects**

"Do you approve amending the Constitution to dedicate all moneys collected by the State relating to natural resource damages in cases of contamination of the environment? The moneys would have to be used to repair, restore, replace, or preserve the State's natural resources. The moneys may also be used to pay legal or other costs incurred by the State in pursuing its claims".

This is written fairly straight forward. The need for this amendment is a result of multiple cases against Exxon for polluting the Passaic River. Without this limitation, Governor Christie planned to spend only \$103



#### Oil Drilling is Not Safe for People or Planet

On Friday the 13th of October a massive oil "leak" was reported in the deep ocean in the Gulf of Mexico by oil drilling giant LLOG Exploration, LLC. The "reported" leaked amount is nearly 672,000 gallons at 5,000 feet below sea level. The leak was caused by a pipeline fracture, although the infrastructure was practically brand new. The location of the spill was just a few miles away from BP oil spill. Just days later, on October 15, a gas drilling rig exploded in Lake Pontchartrain, Louisiana, with 8 men aboard. One father of three was killed and five seriously injured workers were rushed to the hospital. It is still under investigation.

million of the \$580 million received on restoration. The case is being appealed, but clearly funds that are a result of environmental damage should be directed to restore the areas, and payback the legal costs.

#### Monmouth County Ballot Question: Protect Open Space, Water, and Floodplains

It's not too late to save our remaining open lands, protect our water quality, and ensure our property taxes are kept in check by avoiding overdevelopment. A newly formed group Save Open Space in Monmouth County has formed for the sole purpose of guaranteeing that sufficient funds are available to protect our dwindling natural resources in Monmouth County.

Listed as the last question on the ballot, voters are being asked to continue their support through an increased dedication in the annual collection rate that translates to approximately 16 cents to the average taxpayer. The Monmouth County Open Space Trust Fund provides funding to guarantee residents have permanently preserved lands for recreation, water quality protection, floodplain protection, and to maintain the operations of a nationally accredited park system. Since its inception in 1989, the Trust Fund has maintained a clean record of public spending. Spending decisions are carefully overseen by a public board with numerous citizen representatives in order to properly use and allocate the fund.

# Rally Across the Boards: A Five Year Commemoration of Superstorm Sandy

A resident who lost his house during Superstorm Sandy, local officials who led their community's recovery, and activists who know New Jersey is as vulnerable today as it was five years ago rallied at the Paramount Theatre on Sunday to demand immediate action on climate change.

The Superstorm Sandy event – Hands Across the Boards: 5 Years After Sandy – was organized by the New Jersey League of Conservation Voters Education Fund to commemorate the lives, properties, and businesses lost, and to draw attention to ongoing recovery work and lack of preparedness for the next major storm.

Due to another late October storm threatening heavy rain and gusty winds on the anniversary of Sandy, the event was moved from the boardwalk to indoors.

# Shrewsbury Dredging to Feed Monmouth Beach Shoreline

Imminently, the New Jersey Department of Transportation (NJDOT) will begin sand shoal maintenance dredging in three NJ state navigation channels in the Shrewsbury River. Phase 1 of the NJDOT Channel Dredging Program in response to the impacts from SuperStorm Sandy must be completed by December 31st, 2017 per state and federal regulations.

The three channels that will be dredged are: (i) Monmouth Beach Channel (#016) in the Boroughs of Monmouth Beach and Sea Bright, to a maximum depth of 6-ft below the Plane of Mean Low Water Level (MLW); (ii) Rumson Country Club Y Channel (#017) in

the Boroughs of Rumson and Sea Bright, to a maximum depth of 5-ft MLW; and (iii) Oceanport Creek Entry Channel (#025) in the Borough of Oceanport, to a maximum depth of 4-ft MLW. According to the permit details, approximately 17.500 cubic vards is estimated to be removed from the three channels according to the permit details. Only certain areas qualify for beach replenishment. All material dredged must be greater than 90% sand to meet criteria for beach replenishment nourishment along the shoreline of Monmouth Beach, in front of the existing dune between Central and Park Road. Hydraulic dredging will be used to dredge material that will then be transported via pipeline to the

A pre-dredging biological survey was conducted on Sep 19, 2017 by a consulting firm to look for seabeach amaranth, a plant that is on the federal "threatened" plants list. The survey identified 2 areas of seabeach amaranth, with a total of four plants. These were documented earlier by the US Fish & Wildlife Service and fenced off. In addition, the permit requires that shellfish waters shall be closed until 30 days after dredging has been completed. Once the beach replenishment is nearing completion, the area will be inspected for any unexpected changes in habitat. Clean Ocean Action and partners will be monitoring the process carefully. In addition, COA urges citizens who are regularly in the Shrewsbury River and walking along the shore in Monmouth Beach to keep a safe distance, but also a watchful eye.
